We have audited the books of accounts of "Shri Hurakadli Ajja Shikshana Samiti's Smt K.S Jigalur Arts & Dr. (Smt) S.M Sheshgiri Commerce College for Women, Dharwad." for year ending 31.03.2023 and report as under:

1) Income & Expenditure Account:

The accumulated Deficit stood at ₹ 54,02,089.86 at the beginning of the year. During the year under audit, the institution has gross receipts of ₹ 2,76,84,769.00 the total expenditure is ₹ 2,82,15,879.94 resulting in deficit of ₹ 5,31,110.94. Hence the accumulated Deficit is ₹ 59,33,200.80 at the end of the year.

- 2) We have obtained all the information and explanations which to the best of our knowledge and belief were necessary for the purpose of our audit.
- 3) In our opinion, proper books of account have been maintained by the institution, so far as appears from our examination of those books.

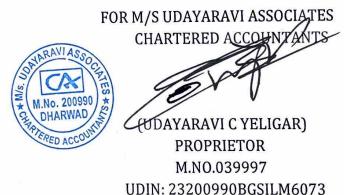
